- TEAMS WILL CONSIST OF 7-10 PLAYERS. GAME IS 4 V. 4 PLUS GOALKEEPERS
- TWO 20 MINUTE RUNNING CLOCK HALVES WITH 3 MINUTE HALFTIME
- ONE REFEREE WILL BE PROVIDED FOR EACH GAME
- PLAYERS MAY PLAY UP IN AGE, BUT NOT PLAY DOWN
- PLAYERS MAY ONLY BE ROSTERED ON ONE TEAM
- EW SURF RESERVES THE RIGHT TO COMBINE OR DROP DIVISIONS WHERE NECESSARY

This waiver and release shall apply to injuries resulting or in part from negligence on the part of EW Surf Soccer Club, its officers, directors, and employees.
